Dropout prevention advocate, Carol F. Lewis, to succeed founding president

**ATLANTA** – Communities In Schools (CIS) of Georgia, one of the nation's leading dropout prevention networks, announced that Carol F. Lewis has been selected to lead the organization following the retirement of founding president, Neil Shorthouse, on August 1, 2014.

Lewis is a 20 year veteran of CIS, having most recently served the past five years as Chief Operating Officer at CIS of Georgia. She has held positions of increasing responsibility within Communities In Schools of Georgia regionally and locally, including serving as an executive director of a local affiliate and a fundraiser within the state office.

During her 14-year tenure with CIS of Georgia, she excelled at connecting the mission with strategic planning, and has been a leading force in driving quality standards across the state organization's affiliates.

Lewis was selected following a national search that included over 200 sources and prospects from at least 18 states. CIS of Georgia was advised throughout the search by BoardWalk Consulting, an executive search firm which specializes in nonprofit leadership.
